Donna will have recruits for the ribbon exchange booth.

Donna suggested having T-shirts and Sweatshirts made in recognition of our 60th anniversary. Finney's one time fee is \$15.00 for one side and \$25.00 for two sides. They can make them for \$8.00/piece for T-shirts and club will sell for more. Donna will get prices and will let us know at the banquet and will bring examples.

Billy made the motion and Wayne 2nd the motion to use black sweatshirts with gold lettering for the members. T-shirts will/can be other colors and will be with or without 60th anniversary logo.
