It was discussed that on Saturday night, after show, the club may have salads, wings, meat platter, KFC chicken...for club members only. This will be decided at a later meeting. We will check with Billy on utensils, paper plates etc. If we do, Rene said she will make desserts.

Next meeting we will work on setting up workers. Jill is working on getting patterns from Horse show patterns.com and show horse promotions.com. Both are free.

Billy confirmed with Francesca. She will be helping Holly in announcer booth.

Nancy will send out a spreadsheet to members for job duties at show. She will also give Amanda the list of class sponsors so she will know how much credit members have earned.

Joyce has big garbage bags that we are going to try in the garbage containers.

Joyce confirmed with Northern Sanitation on the dumpster.

Next meeting will be clean up meeting on Monday night June 16th. Next meeting after that will be October 7, 2014. De made the motion to adjourn at 8:45, and Joyce 2nd the motion.

Treasurers' Report: Show was around \$4,380.00. Refund for clean stalls \$460.00, campers \$625.00, Shavings \$270.00. Will have completed figures for October meeting.

Proposals for New Memberships: Rene proposed Clyde, Kathy & Maria Vincelette. Craig proposed Jim, Cindy & Mikaliah Donah. These two families will be invited to the next meeting in October. Larry proposed Beth & Deanna Mumley. Because they attended the clean up meeting they will be voted on at the October meeting, and notified of the results for the November meeting.

Old Business: Shauna thanked everyone for their support. We had a good show, good weather and good help.

New Business: Craig made the motion and Rene 2nd the motion to combine the show and pattern booklets into one booklet. For the patterns booklet Staples charged us \$3.00 each, and the show program was a total of \$237.00. Seventy (70) booklets will be ordered for 2015. It was suggested to put a pattern on one side and a sponsor on the other side.

19 and over classes will now follow pony classes instead of 13 & under classes following right after the pony classes. It will prevent a lot of tack change delays and give the exhibitors that are in both classes more time to get ready.

The Appaloosa and Paint Pleasure classes will be changed to before the equitation classes.

If more than 12 entries in the Novice classes they will be split.

Shauna made the motion and Jason 2nd the motion that we change the overall schedule for the show.

We have yet to work out all the details, but suggested that:

Saturday may be Halter, English, and Trail classes

Sunday may be Western

There will be the same two judges for both days.

The show, for each day, will get done earlier, and horses and exhibitors won't be so tired. It may also allow for some fun classes like Jack Benny, egg & spoon etc.

If all works out, the following year we can put Western on Saturday, and English on Sunday.

We also discussed looking into adding a class fund raiser for a cause.

Jason made the motion and Rene 2nd the motion to changed Walk/Trot trail to any age.

Pre-entries will be same price, but new entries/exhibitors during show will be \$1.00 more. If already pre-entered, and adding classes there won't be an additional \$1.00 fee added.

Larry made the motion and Rene 2nd the motion that members will not be charged for use of their stall, but if non-members are using the same horse and are in more classes than member there will be a stall charge to non-member. Each member is allowed a tack stall only if there are enough stalls for every exhibitor.

Stall name tags can be done before Friday. Still no horses before Noon on Friday.
